The Clerk was instructed to write to SCC and express the disappointment of the PC and ask who would be the contact between the Mary Howard School and the PC.

### **8 Councillor’s business**

Councillor Elverson reported that he was receiving enquiries from ex-residents for the web site and for the history of the Village. He had replaced the Open Gardens on the home page with Ken Pilgrim’s report. The Chairman advised that M. Ellis had praised the quality of the web site. Councillor Cliffe asked if there was any news on the Village sign. Paul pointed out that he was waiting for the BKV result. It was agreed that the Village sign would be on the next agenda. Councillor Dhillon was pleased to report that the Open Gardens had generated a profit of £4,250. The financial position of the Village Hall was very positive. He had received a report from consultants, who had been looking at the Village Hall, which he will pass around the PC. The new kitchen was planned for September and he pointed out that the planning application to demolish two houses in Pessall Lane and erect four in place was causing residents the utmost concern, all of whom had objected. The next barn dance had been arranged for 2 October. Councillor Cliffe concurred with Councillor Dhillon, that the planning application referred to above, was causing uproar with the residents.

Councillor Mason advised that the Lullington Road sign had been installed. It was agreed that Greenlands would cut the Harlaston Road grass and a metre of grass along the service road of Croxall Road, under the lengthsman agreement. She confirmed that the BKV presentation was scheduled for 2 August. She asked if there was any news on Regional Transport and it was pointed out that M. Ellis had so much on-going, at present, that this item had to wait for the time being.

The Chairman reported that a parishioner had spoken to her, giving details of another incident of inconsiderate driving by the owner of the portaloos business, which had been reported to PC Allsop. Other Councillors also had details of people who had, since the last meeting, experienced similar problems. It was agreed that the Clerk would write to PC Allsop, copy to Inspector White asking what action they could take. She felt that the Church were remiss in not acknowledging the contribution that the PC had made, whilst thanking other bodies in articles in the last two issues of the Mease Valley News. The Clerk will write to the Church treasurer. She asked for a “beware of walkers” sign to be installed in Pessall Lane. It was agreed that Councillor Lacey would be asked to look at the possibility of moving the Raddle Lane sign back from the road, to avoid further damage.
