**1 Apologies received**

**2 Absence noted and approved**

**3 Approval of minutes of Parish Council held on 10 October 2011.**

The minutes of the Parish Council meeting held on 10 October 2011 were approved and signed by the Chairman.

**4 Declaration of interests**

**5 Public session**

Mr P Elverson mentioned the report in the Village Market publication concerning Smart water. The report stated that Smart Water seems not to be as effective as it initially seemed to be.

The Chairman has attended two presentations on Smart Water and still believes it is worth promoting in Edingale.

**6 Clerk's report**

The Clerk advised that the village sign has been erected.

The Clerk wished to record the Parish Council's thanks to Mr Elverson for the suggestion of the sign and for designing it. The sign cost £1,100 and County Councillor Ellis will contribute £800 towards this cost.

It was reported that villagers have commented on the new sign favourably. It was agreed that a debate should be had as to whether the Parish Council should pay for a similar sign for the other end of the village.

Snowplough contractor - A letter had been received enquiring whether there is anyone who may be interested in snowploughing the village in the event of snow. Mr Startin took the letter and will consider whether he is able to carry out this task.

Bridge over the river - The bridge is in poor state of repair. Staffordshire County Council (SCC) are aware of this and intend to build a new bridge but there is insufficient money available for such a project. County Councillor Ellis enquired whether Mr Catmur could obtain a quote from a carpenter to repair the bridge rather than re-build it. The quote has been received and totals £5,000. This has been left with County Councillor Ellis to discuss with SCC.

### **7 Correspondence**

There has been a request from Milly of the Village Hall Committee asking if there is anyone who would volunteer to go on the Village Hall Committee. Councillor Dhillon said that he would be willing to volunteer to attend meetings in the event of no one else volunteering.

There has been a request to 'Plant a tree' at the cycle path in Ashby. The Chairman agreed to put this on the Notice Board in the village.

### **8 Councillors' Business**

Councillor Startin commented that the Zumba class has now reconvened.

Mrs Cliffe mentioned that the Village Market had done a report on the new chicken farm opening off Sysercote Lane in Haunton.  
Also, the Christmas Fayre is to be held on Saturday 26 November from 11.00am - 3.00pm.

Mrs Mason informed the Parish Council that Lichfield District Council have approved 4 houses to be built in Pessall Lane.

Having checked the grit box, Mrs Mason can confirm that it is full.

Mrs Mason also asked for clarification on how much she could spend on flowers for the tubs around the village. The Parish Council informed her that there is money to spend as and when she needs it for flowers for the tubs.

The Chairman confirmed that all letters were delivered by hand to all residents living at numbers: 2,4,6,8 and 10 Rowley Close on 31 October 2011.

It was agreed that the clerk would send a reminder letter to all residents living at the above in December to remind them a response is required by 31 December 2011.

The new Clerk confirmed that she would send minutes to Mr P Elverson.

### **9 Co-opting a Councillor**

Mrs Mason confirmed that she had approached Mr Simon Sprawson to co-opt him onto the Parish Council. He is keen to be co-opted but is unable to attend the December meeting. He can, however, attend in January. The Clerk is to write to him on behalf of the Parish Council.
